Applying the Newtons 2nd law to the floater, the motion of a point absorber WEC can be described in general by the following equation:

$$M \ddot{\zeta}(t) = F_h(t) + F_g(t) + F_{pto}(t) + F_{ext} \quad (2.1)$$

where M is the inertial matrix, ζ is the displacement of the floater, relative to its hydrostatic equilibrium position, F_h is the hydrodynamic force, F_g is the gravity force, $F_{PTO}(t)$ is the force exerted by the power take-off system (described in section XXX, control input), and F_{ext} group all possible external forces. This latter may include, but not limited to, mooring and other potentially non-linear forces, for example, end-stop forces.




Figure 4.1.: Classification of wave energy converters by site of deployment. Extracted from [\[5\]](#)
